- The grade appeal shall be considered, and normally a decision is rendered within 10 working days from the date Office of the Registrar notifies the Dean or designate of the grade appeal.
- Appeal decisions are final and binding. The Dean shall advise the student in writing of the appeal decision.
- A student who accepts a method to remedy a course deficiency, and who is not successful, is not eligible to appeal the original grade. Likewise, a student who is unsuccessful in appealing a grade will be unable to request a remedy of course deficiency.
- A student who received a final grade as a result of academic or non-academic conduct are not eligible to appeal their grade.
